What kind of personal data do we collect?

ProComp S.r.l. only collects basic personal information about you (such as name, date of birth, corporate role, email address and basic contact details, phone numbers, bank data – as well as any other information that you choose to provide) and only in the following ways:

- Information that you yourself provide through our website, on paper, via telephone, at our events or through other means; or
- Through the signing of a supply contract

We will not ask for, and do not intend to collect, any sensitive personal information about you.

Why do we collect personal information?/For what purpose can your personal data be used?

ProComp S.r.l. collects your personal data in order to best respond to the requests you make us and to provide you with information concerning our services (such as informations about our products and services, event invitations, etc.) or to provide the service for which ProComp srl qualifies as your provider.

Your personal data are primarily collected to provide for the following services without needing your declared consensus (art. 6 lect. b), e) GDPR), for the following purpose service:

- conclude the contracts for the services of the Holder;
- fulfil the pre-contractual, contractual and fiscal obligations derived from the relations with you;
- fulfil the legal obligations provided for by the law, a Regulation by the Community legislation or by an order from the authorities;
- exercise the rights of the Holder such as, for example, the right of defense in a court;

How is your personal information protected?

ProComp S.r.l. uses a vast array of technical and organisational security measures with the purpose of improving the protection and the maintenance of security, integrity and accessibility of your personal data.

Your personal data are stored on a server located inside the European Union.

We commit to make sure that in the case that external service providers, which we use to manage our Websites, process your personal information as part of the services they provide to us, they comply with this Privacy notice.

ProComp S.r.l. only uses technical and analytical cookies to ensure the correct functioning of the website.

Access to data

Your data can be made accessible:

1. to employees and collaborators of the Holder or the companies of the group in Italy, as the internal responsible of the treatment and/or the system administrators;
2. to third party firms and other subjects (for information: credit institutes, law firms, external consultants to ProComp srl group,) which carry out activities in outsourcing on behalf of the Holder, as external responsible of the treatment.

How long do we keep your personal information?

What are your legal rights concerning data protection?
